The Applicant and his/her family agree that the FSC, its officers, trip/activity leaders, members and agents shall not be liable or responsible for, and applicant shall save and hold them harmless from and against, any and all claims and damages of every kind for injury to or death of any person or persons and for damage to or loss of property, whether or not caused by the negligence of the FSC, arising out of, or attributing directly or indirectly to, the operations, event, or events conducted by the FSC of which the Applicant or his/her family members are participants whether organized as a formal FSC sponsored event or an impromptu event organized between members.
